CILEx Regulation Webinar - 2 October 2023

Questions asked before and during the Webinar with CRL's Responses



Introduction

As each of the presenters said in the webinar, the issues raised in <u>CILEX's consultation</u> affects all CILEX members. You can access the slides from the presentation <u>here</u>.

Our key message from the webinar is that you need to respond to the consultation to make your voice heard.

CRL believes that these are the key questions which CILEX members will expect CILEX to answer:

- How will a change of regulator improve regulation either for members or consumers?
- Will the 7,000 CILEX Fellows lose the input into regulatory decisions that they currently have?
- Will CILEX's 9,500 paralegal members lose access to the voluntary, independent regulation that CRL currently provides?
- How will the public interest be served by making this change?
- How will SRA champion interests of CILEX members. CRL has committed to a new champion post to do this. Will SRA commit to do same?
- How much will the change cost and who will pay?

We have set out below our answers to the questions you raised both before and during the webinar (those raised in the webinar have been clearly identified).

	Risks	
		CRL considers there is insufficient detail and analysis in both the <u>CILEX</u> and <u>SRA</u> Consultations to enable a reasoned and evidence based decision to be made.
4.	I would be interested to hear what CILEx Regulation believe the potential risks and adverse implications of the planned changes to be.	Neither the CILEX nor SRA proposals have been costed nor have impact assessments been published. It is also surprising to CRL that CILEX have stated clearly that the decision it has to make 'is not a matter of choice or preference of our members'.
		We have set out above the key questions which we believed should be answered before any decision is made.
		The questions set out below identify the issues which are of concern to the profession:

Would CILEX Regulation disappear entirely if the change goes ahead?	CILEX has delegated its regulatory functions to CRL, a company limited by guarantee. CILEX is the sole shareholder of CRL. Although this has to date not been discussed it is likely that CRL would be wound up if it no longer had any regulatory functions.
6.	Webinar Question - Hello all. Apologies, new Paralegal member here so bear with me. Who will ultimately make the call / decision if CILEX & CRL cannot align and agree on this? The LSB?	Ultimately, the Court may be asked to determine the issue.

7.	 In the merger of CILEX with SRA, will CILEX fellows who specialise in commercial contracting continue to be regarded as lesser speciality than a fellow who is a conveyancer or fellow who has a criminal law speciality Will there be a tiering system applied to the roles after the merger of CILEX with SRA so a CILEX fellow is equivalent to a solicitor in grading? 	The proposal is that CILEX re-delegates its regulatory functions to the SRA. No suggestion has been made that there would be a merger. CILEX would continue with its representative functions and continue as the approved regulator.

	Practice Rights

Why have the qualification changed or to be changed to allow new CILEX to automatically have their practice rights, when those who have qualified and has experience still have to complete a course/submit a portfolio and pay £500 I have tried several times to get clarity as to how someone like me that passed levels one and two legal practise and law papers in 1990-1991 and higher law diploma Tort in 1992. I tried making an enquiry but it was 3 years ago in covid period and I could not speak to anyone, it was all via email and CILEX portal. I did not get a clear answer and things have changed again. I have now been offered the law apprenticeship to qualify as a solicitor and looking into this now to make a final decision. I qualified to ACILEX back in the 90s and was part way in the final higher diploma level but placed my further academics on hold as my father passed very young and unexpectedly, I then had a family of my own and carried on working and bringing up a family. They are all adults now and I have the time to finish higher level qualifications so I am no longer held back on various practical working processes. Many thanks. 21.	I note that the Consultation recognises that the current requirements for Chartered Legal Executives to obtain practice rights, is proving to be a barrier. I used to undertake advocacy many years ago but my role does not now require it. Even if I undertake the advocacy course, I then have to show I am using the skills, which I cannot do as it is outside of my role. I believe that this requirement is therefore discriminatory against experience and age. Is the intention to specifically address this? I do not see why a Chartered Legal Executive cannot obtain practice rights, WITHOUT advocacy rights, on the basis they instruct a suitably qualified advocate when required?
