Legal Services Board

- 1. Meetings took place on the 24th July and 31St August 2023 between the LSB, CRL and CILEx to review the timetable and action plan following the recommendations published in the LSB investigation report.
- 2. A meeting in person has been arranged between the CRL Interim CEO, CRL Chairman and LSB counterparts on 5th October.
- 3. The CRL Interim CEO attended the Market Transparency Co-Ordination and Oversight Group (MTCOG) meeting on 26th July.

- 4. A detailed response was submitted to the LSB's Regulatory Performance Assessment Information request.
- 5. The LSB/CRL regular relationship management meeting took place on 13th July 2023. The next meeting will be held on 15th September 2023.

CILEX

- 6. Ongoing fortnightly meetings between the CRL Interim CEO and the CILEX CEO are taking place. The focus being on PCF refunds, Reserves, Communications and consultations etc.
- 7. The CRL Interim CEO attended the Lancashire & Cumbria CILEX Network Launch on 27th June.

- 9. The CRL Interim CEO will be attending all dates for the CILEX consultation roadshow events and webinars.
