#### (A) EDUCATION

#### **Apprenticeships**

- 1. Work on development of a suitable End-point Assessment tool for Advocacy continues for the new Level 7 Chartered Legal Executive Litigator and Advocate Apprenticeship Standard. However, as the current Advocacy Qualification Scheme document has not been updated by the LSB since approval in 2014, the proposed alternations to the Certificate of Eligibility requirements and assessment model will require an LSB Alteration Application. This is planned for Q4 2024.
- Consultation with Apprenticeship Assessors on the portfolio requirements of the new Education Standards which are part of the updated Level 6 and new Level 7 Apprenticeship Standards has started. Specific Guidance on assessment of

Emotional Competence, Conduct and Ethics, and IT has been developed and published.

#### Higher Rights of Audience

- 3. Work continues with the identified training provider for a September 2024 launch.
- 4. To date, we have:
  - Agreed that CRL members will be added into cohorts of solicitors undertaking the training and assessment as CRL higher rights standards have been mapped against the equivalent SRA standards.
  - Agreed that CRL members will be obliged to undertake both the training and assessment and do not have the option to undertake just the assessment component as solicitors can.
  - Agreed that fees charged to CRL members will be the same as those charged to SRA members.
  - Proposed wording for the training provider's website has been developed and is under review.
  - Started to explore dates for academic year 2024/2025 with intention of offering 4 windows of training and assessment with both the option of online and face-to-face delivery methods.
  - Commenced contract drafting.

#### New Education Standards

- 5. The new Education Standards were approved by the LSB in June 2021. Unfortunately, when LSB application was submitted, the 9 individual pathways and the Probate Handbook annexes contained a number of errors which we are in the process of correcting, including:

- The 9 handbooks were not updated to reflect the LSB approved (January 2023) move from Qualifying Employment to Qualifying Experience as an experience requirement
- Each of the 9 pathways has a common core of competencies and outcomes but have slightly differently wording or punctuation in several (or all) of the pathways. We have undertaken an exercise to identify the most appropriate presentation of each competency and outcome and applied it to each pathway

- Rights of audience requirements are included in both the Immigration and Employment pathway, but no reason has been identified as to why. We have sought advice from external advisor.
- Applicants are advised to compile portfolios to demonstrate evidence against the competencies and outcomes within each pathway but for the contentious pathways (civil, criminal and family), it is not clear what evidence can be submitted prior to applicants undertaking the advocacy training and assessment. Again, clarification has been sought from our external advisers.
- 7. As the Probate Handbook and the 9 individual pathways were submitted to the LSB as part of the approval application in 2021, any amendment requires their approval. An application will be submitted to the LSB in Q3 2024 covering all corrections and updates.
- 8. This application will also include the required amendments to the legacy Immigration Practice Rights Handbooks as it currently includes practice rights that can only be exercised by members with rights of audience which we cannot authorise.

#### (B) POLICY

## **Equality Diversity and Inclusion**

- 9. CRL took part in a meeting with LSB, SRA and ICAEW to discuss the possible changes to disability and religion questions proposed at the Judicial Diversity Forum Combined Statistics Working Group (CSWG).
- 10. CRL participated in the Legal Regulators EDI Forum May meeting. Discussions focused on the current approach to diversity data collection, continued harmonising of data collection, inclusion metrics and potential changes to the disability and religion questions raised by the CSWG.

#### Consumer

- 11. The collaborative digital exclusion research with BSB, CLC and ICAEW progressed with MEL research sharing feedback on stakeholder interviews. CRL participated in a meeting to discuss participant research questions for field work commenced in June.
- 12. The consultation on proposed changes to the Transparency Rules and CILEX-ACCA Probate firms Regulations was open for six weeks between 20 May 2024 and 1 July. The consultation was communicated to the regulated community via a range of different approaches. Additional specific communications were directed to CILEX Authorised firms and CILEX-ACCA Probate firms.

- 13. CRL is a member of the Regulatory Information Service (RIS) project data group. The discovery phase continued at pace during April and May. CRL participated in several one-to-one meetings with the project manager and group discussions to establish minimum viable product (MVP) across all regulators.
- 14. CRL took part in May's meeting of the Legal Choices Steering group. Discussions included progress against the delivery plan, budget, and website traffic. The RIS discovery activities and MVP were considered and there was agreement to move the project forwards to the design stage.

## 17. Work has also continued on ongoing projects including:

- c) Review of the Regulation Matters website due to continued low engagement we are considering the possible decommissioning of the site. Options discussed with Spindogs include moving content to the main CRL website or setting up a microsite. Currently reviewing feasibility, risk, costings etc with Spindogs.
- d) **Citizens Advice website** in contact with Citizens Advice to see if we can have a link to the CRL website from their main site.
- e) **Accessibility** messaging to increase awareness of our ReachDeck product including translation functionality.

CRL's communication channels continue to show steady engagement across our main platforms, including the CRL website, social media and newsletters.
