### **PURPOSE OF REPORT:**

1. This paper provides the Board with a proposal for review of the fees paid to assessors and the fees charged to applicants for a range of different applications.

#### **INTRODUCTION:**

2. This paper sets out a proposal for an increase in fees paid to assessors which reflects the time spent in determining the various applications, and in the application fees the time spent by CRL, as well as the change in assessor fees. Various media will be utilised to ensure that applicants and potential applicants are given prompt notice of the intended changes as far ahead as possible of the changes coming into effect.

#### **RECOMMENDATION:**

3. The Board is asked to **APPROVE** the proposal.

#### TIMING OF CHANGE IN ASSESSOR FEES AND APPLICATION FEES

4. The immediate pressure for reviewing fees has come from the assessors because

- a. The fee rates have not been reviewed for some years
- b. The changes in assessment requirements, particularly the introduction of CPQ, means that some assessments are taking significantly longer than previously
- c. The assessor fees paid by CRL are less than the commensurate fees paid by CILEX.
- 5. It is proposed that the increased fees payable to assessors come into force on 1 May 2025 and for applicants on 1 July 2025 so reasonable notice is given of the increase in fees.

### **Explanation for proposed changes**

7. The changes proposed are explained as follows:

#### **Qualifying Experience**

a) No change is proposed to the current fee of £89 per application as this was increased from £85 in 2024.

#### **Certificates of Eligibility**

- b) The proposed increase in the fee paid to External Experts reflects the time required to assess:
  - up to 8 portfolios submitted with the Certificate of Eligibility Application Form, and
  - ii. the readiness of the applicant to be authorised as a Litigation Practitioner and undertake the Advocacy Skills Course.

The increase in the application fee reflects the additional time spent by CRL.

# **Work-based Learning (Legacy Standards)**

c) The proposed increase in fees charged to members and fees payable to External Assessors is based on reports by the current External Assessors that it takes between 2 and 4.5 hours to assess a portfolio. At an average of 4 hours at £50 per hour results in a fee of £200 for the External Assessors plus an additional fee of £75 if they ask for additional information from the applicant which needs further assessment. This aligns with the fees proposed for External Assessors for assessment of Specialist Pathways in the new Education Standards.

### **Practice Rights (Legacy Standards)**

d) No increase is proposed in the application fee of £450. It is proposed that the External Assessor fee is increased to reflect that it takes between 2 and 4 hours to assess portfolios.

### **Specialist Pathways (new Education Standards)**

- e) The application fee proposed (£450) is the same proposed in <a href="CRL's application">CRL's application</a>¹ to the LSB for authorisation of the new Education Standards in 2021. Although the fee was approved by the LSB, the fee charged has been £336, the same fee as for Work-based Learning portfolios.
- f) The increase proposed to the External Assessor fee reflects the time taken to assess the Specialist Pathways portfolios (between 2 and 4 hours) and to match the fees that CILEX will be paying Apprenticeship External Assessors. As these standards are new, it is proposed that External Assessors are paid £300 for the first 10 portfolios they complete to allow time for each External Assessor to become familiar with the requirements. Again, this is in line with CILEX's fee proposal. The £75 fee is only paid if the External Assessor asks for additional information from the applicant which needs further assessment.

## **Advocacy Certificate Renewal**

g) The increase proposed in the External Expert fee reflects the time taken to assess 3 advocacy cases undertaken by the applicant in their first year exercising rights of audience and assess whether sufficient information has been provided for advocacy practice rights to be continued.

#### **COST IMPLICATION OF PROPOSAL**

- 8. Net of the cost of assessor fees, the budgeted income for application fees for the period 1 May 2025 to 31 December 2025 is currently £135,024.86 (based on the six applications addressed in this paper). If, as proposed, assessor fees increase with effect from 1 May 2025 and application fees increase with effect from 1 July 2025, CRL's net income for application fees will decrease to £130,094.57, a negative variance of £4,930.29.
- 9. This can be summarised as follows:

- 10. If the Board approves the proposal:
  - a) assessors will be notified promptly and payments of assessor fees will be made at the revised rate(s) with effect from 1 May 2025, and
  - b) applicants and potential applicants will be notified of the revised application fee rates in the monthly CRL newsletter sent in April-July 2025 and on the CRL website, supplemented by a social media campaign.
