# **Overall Programme Status: AMBER**



The main issues to highlight are CILEx's PCF feedback; the ongoing impact of coronavirus on our projects and budget and the enduring lack of PII for entities threatening the viability of entities. Equally, most activities are performing to timeframe and budget with any associated risks being managed via the risk register. Significant achievements include making savings to help our position for 2021; CRM progress on prior conduct, EDI data linked to renewals, risk matrices and directories and the LSB's first stage approval of the alternative route to practice rights application.
