### **Legal Services Board**

#### Applications and submissions

- 1. On 21 January 2022, CILEx Regulation Limited (CRL) submitted an application to the Legal Services Board (LSB) to amend its regulatory arrangements (by exemption) following CILEX's decision to rename its membership grades from 1 January 2022. This application will permit CRL to amend rules and regulations to reflect the new CILEX member grades. A decision is expected by 18 February.
- 2. CRL submitted an application on 27 January 2022 to the LSB for approval of its policy rules and guidance relating to the mutual recognition of professional qualifications (MRPQ). A decision is expected on 23 February.
- 3. An application was submitted on 28 January 2022 to the LSB to extend the temporary alterations to CRL's Enforcement Rules, specifically the provisions that allow for a presumption of remote disciplinary panel hearings owing to the coronavirus pandemic. The extension was requested until 31 August 2022, subject to CRL's intention to submit a full rule change application by that date. The LSB approved the application on 1 February 2022.

### Reports and consultations

- 4. CRL submitted its response to the LSB's consultation on Consumer Empowerment on 18 November 2021. The LSB received 21 responses in total and has indicated that there was general support for the principles outlined in the paper. The final statement will be considered by the LSB Board in March 2022 for publication in April.
- 5. A response to the consultation on the LSB's Business Plan was submitted on 26 January 2022.

6. The Chief Operating Officer has prepared a response for the Board's approval on the LSB's current open consultation on ongoing competence (*infra* at Agenda Item 10).

### Transparency and CMA work

- 7. Phase two of the joint regulator pilot project on 'Quality Indicators' (QI) to which CRL is contributing is continuing well. The project is now exploring firms' willingness to publish objective third-party data and their experiences of the process. Digital comparison sites have indicated that they may use such data in the future but have no current plans to do so. The project team met with Ofcom and Ofgem to gain a better understanding of existing accreditation schemes. Feedback was also provided on the Legal Services Consumer Panel's tracker survey relating to 'shopping around'.
- 8. CRL continues to attend briefing sessions by the Solicitors Regulation Authority (SRA) on its "unbundling" pilot.
- 9. The Chief Executive attended the third meeting of the LSB-led Market Transparency Coordination Group (MTCOG) on 24 January 2022. The following matters were discussed:
  - feedback from the LSB's consultation on empowering consumers
  - the LSB's proposed approach to evaluating its strategy and what measures regulators should have in place for evaluation
  - the update on the quality indicators pilot
  - the SRA's work on its 'unbundling' pilot
  - the report from the Task and Finish Group on the provision of a 'Regulatory Information System' (single digital register)
  - the next meeting of the Public Legal Education Group.
- 10. CRL continues to contribute to the MTCOG Task-and-Finish Group that is carrying out work on the provision of a Regulatory Information Service (formerly single digital register). The group has commenced work on a 'discovery' document which will provide information and policy recommendations to MTCOG, together with a 'proof of concept'.
- 11. On 31 January 2022, the Director of Operations represented the Chief Executive at the second meeting of the MTCOG's Public Legal Education Group led by the Bar Standards Board (BSB). CLR is contributing to the working group on immigration, which seeks to improve information to consumers in this area.
- 12. The extension to CRL's Transparency Rules to include immigration law went live on 24 January 2022. Firms carrying out work in this area have been informed that compliance with the rules is expected as soon as possible. CRL has offered additional support if required.
- 13. Several CRL firms have added the Legal Choices dictionary to their websites after CRL encouraged its use. Following CRL's approach to 140 law clinics, Legal Choices has noted a surge in frontline advisers signing up to the 'App' that asks regular questions to support content development.

### Staffing and operations

### <u>Staffing</u>

- 14. The vacant position of Practitioner, Authorisation and Supervision Officer has been filled. The successful candidate will be joining the team on 28 March 2022.
- 15. The positions of Director of Governance, Policy and Legal and Manager of Policy and Stakeholder Engagement are currently being advertised. Interviews are scheduled to take place on 8 and 11 March.
- 16. The Policy Innovation Officer left CRL on 12 January 2022 after providing one week's notice of her intention to accept a post with the Civil Service. Appointment to this vacant position will be considered following the recruitment process for the Manager of Policy and Stakeholder Engagement.
- 17. The Interim PA to the Chief Executive, Chair and Executive Team has tendered her resignation having been offered a permanent position elsewhere. She will be leaving CRL on 18 February. Interviews are currently taking place for her replacement.

#### **Premises**

18. Following recent Government advice, CRL's Wrest Park office has re-opened and is available for colleagues to book, as required.

## CRM update

19. The Chief Executive and Chief Operating Officer continue to meet weekly with the CILEX Project Co-ordinator. Progress across all areas is continuing well.

Recent issues being addressed include:

- CILEX encountered some problems with renewals this year that affected the accuracy of data at the end of last year.
- Work is continuing on CILEX Learn (the platform to enable WBL portfolio submissions).
- The development of CRL's Portal is in progress to enable applications to be submitted online.
- Risk Matrices work is in the final stages of testing and should go live in March.
- Work on the Entity Directory continues to ensure that it meets LSB requirements.
- Data migration for enforcement is continuing but requires significant resources from the enforcement team to be brought to a conclusion.
- Consideration is being given to take up the option of direct debit payments for CRL, including requirements regarding FCA accreditation.
- A review of prior conduct workflow is in progress, but will require changes to be agreed by the Professional Conduct Panel before implementation.
- Difficulties have arisen with the speed of the Practitioner Directory

20. The Interim Director of Governance has commenced a review of CRL's agreements with CILEX on shared services to ensure that appropriate service-level and operational-level agreements are in place and are working effectively. CILEX has indicated that it wishes to stop providing HR support under the existing agreement from the end of March 2022. The Interim Director of Governance is meeting with the Chief Operation Officer from CILEX this month to discuss the financial and practical implications of such a change.
