Ensuring that the education, training, and ongoing competence requirements of the regulated community are regularly reviewed promotes the protection of the public and consumer interest, access to justice, and encouraging an independent, strong, diverse and effective legal profession.
Implications for Resources	This report covers staffing, operations and resource implications affecting CRL since the last board meeting. These are also covered in more detail in the People Strategy paper at Item 9 [NOT PUBLISHED] . CRL's PCF (practising fee) was approved in December 2022 and, in addition, CRL has both contingency and operating reserves. Therefore, financial resources are satisfactory. IT resourcing generally is satisfactory; however, the shared services element of the CRM remains challenging.

Section One: For Publication

Legal Services Board

- 1. The outcome of the LSB's investigation into CILEX and CRL was published on 18 April 2023.
- 2. The next LSB/CRL relationship management meeting is scheduled for 27 April 2023.

<u>CILEX</u>

3. CRL's Acting CEO and the CILEX CEO have held a series of meetings since 23 March 2023 to discuss collaborative working as part of the conclusion of the LSB's Investigation.

Applications

4. No applications have been submitted to the LSB since the last Board meeting.

Staffing and Operations

- 5. The Acting CEO resigned on 21 March 2023 and will leave the organisation on 16 June 2023, having replaced the permanent CEO on 13 March 2023. An Interim CEO has been appointed with effect from 17 April 2023. A competitive process, in accordance with CRL's Standing Orders, will be conducted later this year to appoint a permanent CEO.
- 6. An offer has been made to replace the Practitioner Authorisation & Supervision Manager who left at the end of March 2023. If the offer is accepted, CRL expects the new Manager to take up the position on 2 May 2023.
- 7. The PA at CRL resigned on 4 April 2023 and will leave the organisation on 2 June 2023. CRL is seeking a replacement PA.
- 8. CRL held a face-to-face staff meeting on 14 March 2023 and an online staff meeting on 13 April 2023.

CRM update

- 9. Meetings with CRL and the CILEX CRM Project coordinator have not been held since December 2022. CRL has now been notified that these services will end in June 2023 and responsibility will transfer to the IT team.
- 10. Key project updates include:
 - a. The online portfolio project is being developed to support apprenticeship delivery, CRL expects that the functionality may assist in the creation of a solution for CRL's portfolio requirements.
 - b. As stated at the last Board meeting, CILEX IT and Silver Bear continue to develop the Entity Directory to enable it to meet LSB requirements. This should have been available to CRL from August 2019. Following the introduction of ACCA firms, additional changes have also been requested. The process has taken longer than anticipated as the ACCA work has been undertaken whilst overlooking the original development work. It is expected that a revised version of the directory will be available for testing shortly. An oral update will be provided to the Board, if available.

Shared Services

- 11. At its April Board meeting, the Board agreed alternative provision for HR services, and this is being pursued by the Acting CEO for implementation. An update will be provided at the July Board meeting.
- 12. Other shared services continue and were agreed as part of the 2023 PCF application.

External meetings

- 13. The Chief Operating Officer and Practitioner Manager met with the SRA on 17 February 2023 to discuss CRL's proposed application to the LSB to obtain Higher Rights of Audience for suitable CILEX members. The discussions were positive, and the SRA supported CRL's application.
- 14. The Chief Operating Officer presented the proposals for the new Chartered Legal Executive Apprenticeship to the Institute for Apprenticeships and Technical Education (IFATE) Route Panel meeting on 24 February 2023. As a result, the Route Panel recommended the creation of the new apprenticeship and the standard continues to progress through IFATE governance.
- 15. CRL has been invited to attend a meeting of the Legal Choices Governance Board on 18 May 2023.
- 16. CRL will be attending the Legal Services Consumer Panel Standardisation of Consumer Information Roundtable on 20 April 2023. An oral update will be provided to the Board.

Education Standards Update

Higher Rights of Audience consultation

- 42. CRL has had a meeting with the SRA to discuss the alignment of CRL's proposed standards for suitably competent chartered legal executives to obtain higher rights of audience. The outcome of the discussion was positive and the possibility of sharing the SRA's training and assessment supplier was also discussed.
- 43. CRL is now working with its external advisers to finalise the draft competence framework, after which this will be put out to consultation for final commentary from a range of stakeholders, prior to submitting an application to the LSB for rule change towards the end of 2023.

Ongoing competence

44. CRL has completed the actions required from Q1 of its action plan. More information will be provided to the Board on progress and proposals at the strategy meeting on 9 May 2023.
