


Q1 Do you consider it to be a priority to change the current regulatory system?



Q9 AGE Which age category are you currently in?



Q10 GENDER Which gender do you identify with?



Q11 Is the gender you identify with the same as your sex registered at birth?







Q14 Sexual Orientation Which of the following best describes your sexual orientation?







Q17 Are your day-to-day activities limited because of a health problem or disability which has lasted, or is expected to last, at least 12 months?





Q19 Which type of school did you attend for the most time between the ages of 11 and 16?



Q20 Did either of your parents attend university and gain a degree (e.g. BA/BSc or equivalent) by the time you were 18?



Q21 Did you gain an undergraduate university degree?



Q22 If you went to university, how was it funded?



Q23 At any point during your school years did your household receive Income Support?



Q24 If you finished school after 1980, were you eligible for free school meals at any point during your school years?



Q25 Caring Responsibilities Are you a primary carer for a child or children under 18?


